



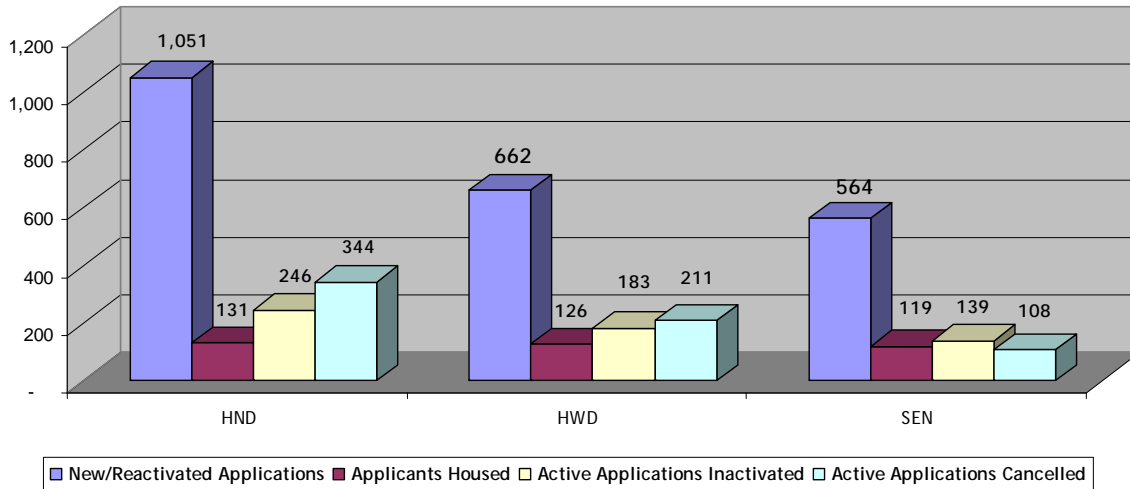

SUMMARY OF ACTIVITIES

Total number of people on Housing Connections centralized waiting list for social housing is 145,419 as of March 31, 2011, compared to 144,159 as at February 28, 2011. The rest of the numbers in this Statistical Report refer to household applications which may have several people on their application.

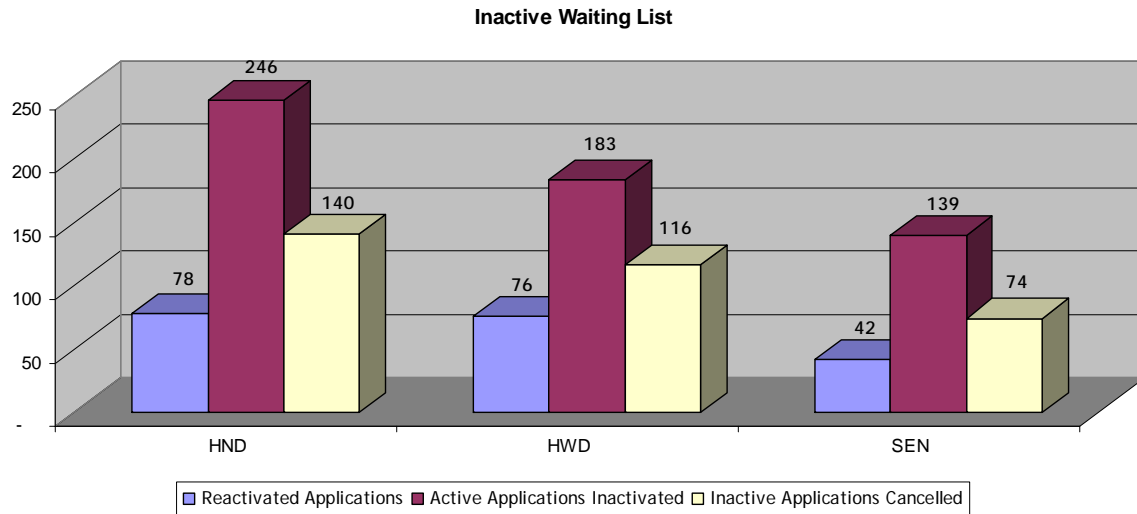

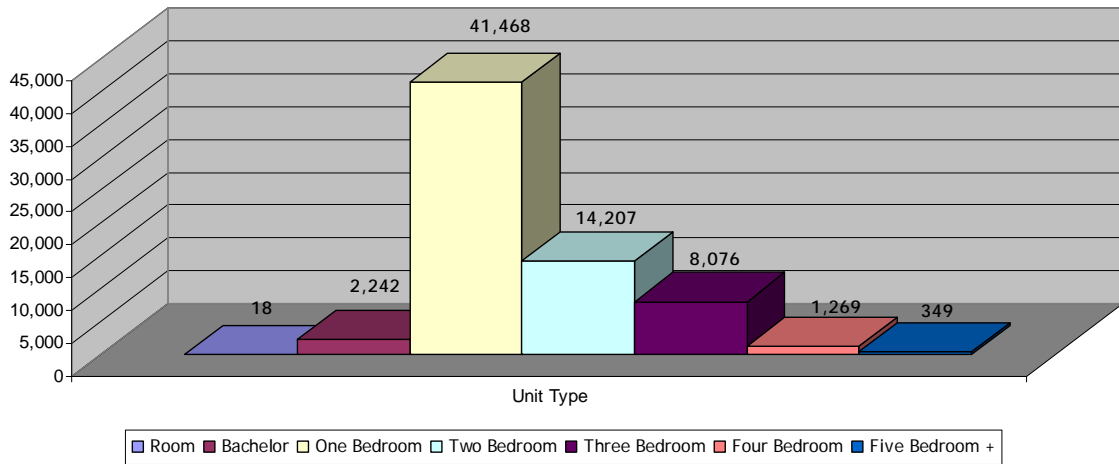

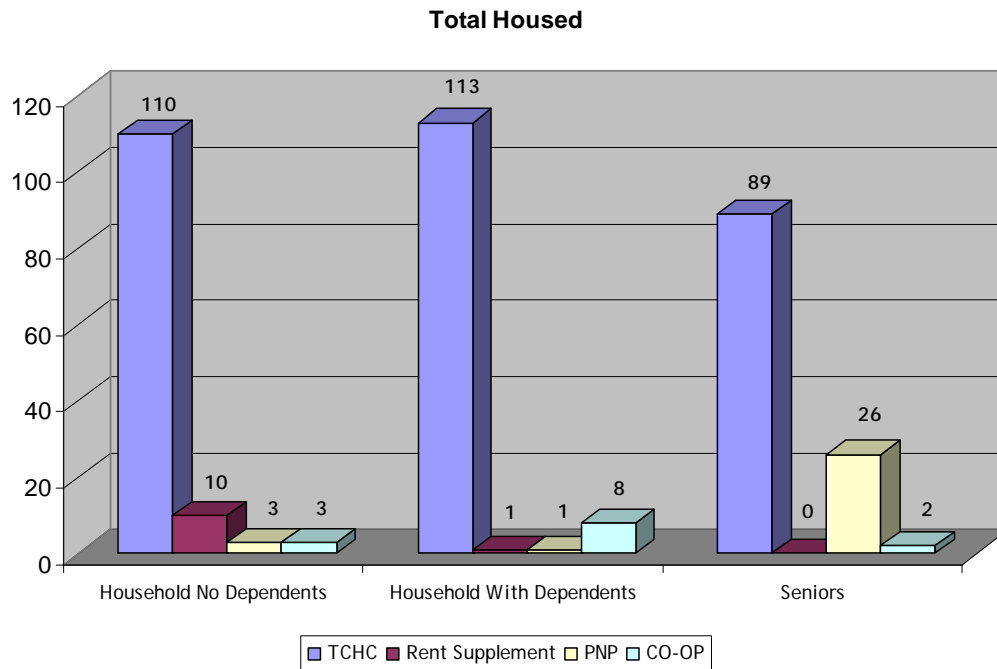
